INSTRUCTIONAL ORDER

**Subject: Implementation of Provisions for Rain Water Harvesting as per amended Delhi Water & Sewer (Tariff & Metering) Regulations, 2012 & Relaxation of condition to ensure RWH System on plot size 100 Sqm and above**

The Board in its meeting held on 04.03.2022 vide Resolution No.1228 has approved to defer levy of penalty in case of non-existence of RWH Structure and mandatory clause for RWH structure before granting new connections on properties on plot size 100 Sqm and above till 30.09.2022.

Rain Water Harvesting cell of DJB, all EEs(Maintenance) and Revenue Officers are directed to give wide publicity and advise the public having properties constructed on plot size 100 Sqm. and above to ensure mandatory installation of Rain Water Harvesting system well before the timelines. Consumers may be guided to avail benefit of 10% rebate on water bills and available financial assistance scheme for adequate and functional RWH system.
