



Delhi State Legal Services Authority organizes Lok Adalats for settlement of all types of pending and pre-litigation Civil and Criminal Compoundable cases regularly every month at all the 11 Districts in Delhi. DSLSA organizes Lok Adalats in District Courts, High Court, Central Administrative Tribunal, District Consumer Disputes Redressal Forums, State Consumer Disputes Redressal Commission, Debt Recovery Tribunals, Company Law Board & Revenue Courts.

This letter is in pursuance of letter sent to your office with reference no. DSLSA/ADRW/NLA/2022 dated 11.04.2022 from the office of Ld. Member Secretary, Delhi State Legal Services Authority, Patiala House Courts. It has been observed and identified after several meetings with the Presiding Officers of Industrial Tribunal & Labour Courts that cases referred to Lok Adalat are not being settled because settlement officers were either not appointed by the departments or though appointed, were not present during the Lok Adalat.
