Circular

As per decision taken by the Competent Authority duly circulated vide no. 24577 to 24838 dated 02-03-2015, seniority list of vacant quarter for allotment will prepare in two blocks i.e. applications during received 16<sup>th</sup> September to 15<sup>th</sup> March and 16<sup>th</sup> March to 15<sup>th</sup> September in a particular year and quarters are allotted according to seniority list. After allotment of vacant quarters in particular Block, seniority list of the said block will be scrapped and fresh seniority list will prepare for the next block.

Accordingly, process of allotment of quarter as per seniority list prepared in respect of applications received upto 15-03-2022 has been completed and the seniority of block 16-03-2021 to 15-09-2021 has also been scrapped.

Now, allotment of quarters for the Block period w.e.f. 16-09-2021 to 15-03-2022 is going to start and for this purpose provisional seniority list of type-I, type-II & type-III as per applications received in the Block period w.e.f. 16-09-2021 to 15-03-2022 through in hard copy, have been prepared.

The above mentioned seniority lists has also been uploaded on the website of DJB portal, under Circular head as well as displayed on the notice board of the office of A.C.(L&E) at Room no. 309, Varunalaya Phase-II. All applicants who have applied during this period are requested to check their details in the seniority list, upto 06:00 pm of 13-05-2022. Thereafter, the list will be finalized and allotment on the basis of that seniority list will be made amongst the vacant quarters, vacated upto 15-03-2022.

All DDO's are requested to give vide publicity of this Circular and also requested to download the seniority list for information to the concerned official working under their control so that any employee may not have any complaint about non information of the circular.
