Subject:-Revised Final Seniority List of Assistant Engineers (Civil) promoted / appointed during the period from 14.11.2007 to 31.10.2018 circulated on 15.01.2019, as per judgement of Hon'ble Supreme Court of India and DoP&T OM dated 04.03.2014 & 13.08.2021.

Whereas, Hon'ble Tribunal vide order dated 11.03.2022 in O. A. No. 2430/2019 in respect of awarding inter-se-seniority and on the basis of DoP&T OM dated 04.03.2014 and DoP&T OM dated 13.08.2021 were passed for respondent (DJB) to consider and dispose off representation from plaintiff by passing an appropriate reasoned and speaking order expeditiously within 10 weeks of receipt of such representation.

AND Whereas, the combined representation addressed to CEO, DJB was received from the applicants in this office on 31.03.2022 and they have requested for fixing their seniority in reference to DoP&T's OM No. 20011/1/2012-Estt.(D) dated 04.03.2014 from the date of advertisement No. 02/2012 of Delhi Subordinate Service Selection Board (DSSSB) with closing date of receipt of applications as 15.06.2012.

AND Whereas, the case has been examined in the light of the provisions of the aforesaid guidelines of Office Memorandum and it has been observed that:-

The requisition for filling up vacant posts of Assistant Engineer(Civil) had been forwarded to DSSSB and issue of advertisement for recruitment of AE(Civil) in DJB in the year 2012. The examination for the said post under post code 02/2012 was conducted by DSSSB and the result was declared on 24.04.2018.

Subsequently, DSSSB had sponsored the names of selected candidates i.e. S/Shri Vishal, Sanjay Sharma, Sanjeev Vashisht, Manoj Kumar Sharma, Rohan Jharkhariya, Pawan Bansal, Sanjay Kumar(SC), Pankaj Kumar (OBC), Rajesh Kumar (SC) and Deepak (SC) vide letter No. F.3(53)/DSSSB/P&P/2008/206 dated 02.05.2018. The joining of all these officers/officials is 06.06.2018 to 24.07.2018, i.e. within the time period prescribed in OM dated 04.03.2014.

Taking into consideration, all the facts and references placed before the Competent Authority, since the case fulfills all the pre-conditions as mandated under OM dated 04.03.2014, so Competent Authority has accorded for granting of inter-se-seniority of the following Assistant Engineer (Civil) from Sl. No. 409, 413, 417, 421, 425, 429, 433, 437 & 441 with effect from Recruitment year 2012 in terms of existing ratio of RR's for the post of Assistant Engineer(Civil) i.e. 3:1 (03 Promottee : 01 Direct).

Accordingly, in terms of OM dated 04.03.2014 and the existing seniority, the revised seniority is as under:-
