
Consequent upon the recommendations of the Selection Committee and further approval of CEO, DJB, Sh. Anil Kumar Gaur, is hereby engaged as Special Advisor to Vice Chairman, DJB purely on contract and co-terminus basis with the tenure of Hon'ble Vice Chairman, DJB Sh. Saurabh Bharadwaj on a monthly remuneration of Rs.1,00,000/- (Rs. One lakh Only). However, no perks/benefits/allowances as admissible to a Govt. Servant like LTC, Travelling Allowance, Conveyance allowance, Transport allowance, Medical, Bonus, HRA etc. will be admissible. Further, the above engagement shall be subject to terms & conditions as mentioned below:-

TERMS & CONDITIONS:-

1. The engagement will be purely on contractual and temporary (Non-official) nature. It will confer no right to appointment or regularization and placement in Delhi Jal Board, on any ground whatsoever.
2. No other allowances or facilities, available to regular employees, shall be payable to person engaged on contract basis unless specifically agreed to.
3. The engagement on contract basis will be on co-terminus basis with the tenure of Sh. Saurabh Bharadwaj, Vice-Chairman, DJB.
4. The engagement on contract basis can be terminated at any time without assigning any notice/reason.
5. The department will not bear any kind of liability/responsibility during the period he/she remains on contractual engagement with Delhi Jal Board except payment of contractual remuneration for his/her service rendered to the department.
6. DJB will not hold any responsibility of incident/accident of the contractual employees during the period of engagement in Delhi Jal Board.
7. If any contractual employee remains absent from duty for more than 30 days continuously without any valid reason, then his/her contractual engagement will automatically stand discontinued.
8. Only one day Casual Leave in a month will be admissible to the contractual employees on pro-rata basis which can be carried forward to following months.
9. No TA/ DA shall be admissible for joining the assignment or on its completion. Advisors/Consultants will not be allowed foreign travel at Government expenditure.

The individual is hereby directed to report to Director (A&P) for further acceptance to the post of Special Advisor to Vice Chairman, DJB contract and co-terminus basis with the tenure of Hon'ble Vice Chairman, DJB, Sh. Saurabh Bharadwaj, within 10 days.




