Guidelines for training programme:

- The participants are expected to come with face-mask and sanitizers.
- (#) Before the entry to the training venue, the participants have to undergo thermal scanning,
- Physical distancing is to be maintained keeping in view the corona pandemic.
- The food, snacks, tea/coffee, water etc. will be served at the training venue. However, it is strongly advised that the proper social distancing needs to be maintained while taking the food items.
- The seating arrangement as prescribed under SOP will be strictly followed.
- After the completion of the sessions, the participants have to leave the training venue one by one and carry their stationery materials and to be brought by themselves every day,
- (vii) The time-schedule of the training is to be followed strictly,
- (viii) Any symptom related to corona if found with the participant, his/her entry would be denied. Such candidate has to go back to and follow the SOP as per guidelines issued for COVID 19.
