

Consequent upon the recommendation of the Departmental Screening Committee and further approval of the Chief Executive Officer, DJB, Sh. K.C. Meena S/o Sh. R.K. Meena, SE(E&M), Emp. Code: 20010911 O/o ACE(P)-3 is hereby promoted to the post of Chief Engineer (E&M) on Ad-hoc basis with immediate effect, initially for a period of one year in the first instance, in Level-14 as per 7th Central Pay Commission Pay Matrix of Rs.144200-218200, plus usual allowances as admissible under the rules or till such time this post is filled in on regular basis through UPSC or till retirement after attaining the age of superannuation or till further orders, whichever is earlier.

Further, the above ad-hoc promotion is subject to the following term & conditions:

- 1. The ad-hoc promotion will not confer any right on the officer to claim for regular promotion to the post or next higher grade or any other service benefit.
- 2. That the period of service rendered on Ad-hoc basis will not count as officiating in the higher grade for any purpose including seniority in that grade.
- The Competent Authority can terminate the above interim/stop gap arrangement at any. time without assigning any reason and giving any prior notice.
- 4. Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
- 5. It is also subject to outcome of pending Court Cases/ Appeal before Hon'ble Court of Law, if any.
