5. In reference to DoP&T's O.M dated 15th June, 2018 bearing No. 36012/11/2016-Estt(Res-i)(Pt-II), Ad-hoc promotion is subject to final outcome of SLP(C) No. 30621 of 2011 pending before Hon'ble Supreme Court and other court case, If any.

6. On conclusion of the disciplinary case/outcome of court case/criminal prosecution which results in dropping of allegation (s) against any senior person, then the junior most officiating person will be reverted.
7. In terms of relevant RRs dated 14.06.2015 all the above official(s) will also required to undergo one week's mandatory training successfully in DJB Training Institute as and when it is organized by the AC(Training)Cell.
