ORDER

Subject: - Clarificatory Order for levy of Infrastructure charges

It is mandate of Delhi Jal Board (DJB) to provide water to each and every household in Delhi through tap connection where water distribution networks are laid and functional subject to payment of applicable connection charges.

2. References are being received in Revenue (HQ) for seeking clarification about levy of Infrastructure Charges (IFC) where applicable i.e. whether IFC will be levied before sanction of water connection or at the time of sanction of water connection or after sanction of water connection.

3. In this regard, Order No. 26 dated 29.12.2021 of worthy CEO, DJB has been issued wherein it has been mentioned that "For the applications for new water connections of the property of plot size more than 200 sq. mtr, the connection will be issued only after the premises have been visited by the JE concerned and Infrastructure Charges, as calculated by the Engineering wing are deposited by the applicant. The visit and calculation should be done within 10 days of application."

The visit and the calculation should be done within 10 days of application.

No connection should be allowed without deposition of Infrastructure Charges for the plot size above 200 sq mtr.
