### ORDER

**Subject:- Financial position of Delhi Jal Board.**

In exercise of its powers under Section 22 of the Delhi Water Board Act, the Board in its 163<sup>rd</sup> meeting held on 10<sup>th</sup> October, 2022 has deliberated on the financial position of the organization as contained in the proposal No.DJB/Dir (F&A) /AO (B&A)/2022/1552 dated 07.10.2022 of Dir.(F&A). The Board noted that loan of approx. 70,000 cr. is a legacy issue and it has accumulated over a period of time since 1933 i.e. even prior to formation of the Board.

The Board vide Resolution No.1311 Item No. Admn.616 dated 07.10.2022 in the 163<sup>rd</sup> meeting held on 10.10.2022 resolved that proposal be moved to the UD Department & Finance Department of GNCT of Delhi for conversion of past accumulated loans including interest amount into grants and provision of funds in the form of Grant in Aid in future. The Board further directed that measures may be taken to bring unbilled consumers/ unauthorized connections into billing network on priority.
