ORDER

In continuation of the earlier orders No.F.36(167)/Coord/Div.Comm/2013/1202 dated 25.4.2015 and No.F.36(167)/Coord/Div.Comm/2013/1277 dated 07.5.2015, Govt. of NCT of Delhi, vide Cabinet Decision No. 3063 dated 25/01/2022 issued vide No. F.03/10/GAD/CN/2021/dsgadiii/109-118 dated 25/01/2022, has approved to pay ex-gratia for crops damaged due to unseasonal rains in Delhi in the year

- A compensation of Rs.20,000/- per acre may be extended to provide the ex-gratia relief (i) of farmers in lieu of damages to crop due to unseasonal rains in the year 2021 as per the below mentioned eligibility conditions:
 - a. The farmer claiming ex-gratia compensation must be the recorded owner of the land whose crops has been damaged due to unseasonal rain in the year 2021.
 - b. The ex-gratia compensation will not be paid to the land owners who are in the nature of companies or whose land has been vested in Gaon Sabha and the vesting order
 - c. Further, the farm houses, which are in the nature of plots with pucca boundary walls, will also be excluded.
- Compensation @ of 70% shall be paid if loss assessed is 70% or less and @ 100% if loss (ii) assessed is more than 70%.
