ORDER

Sub:- Sanction for continuation of temporary posts for the year 2022-23 w.e.f. 01/03/2022 to 28/02/2023 under Plan/Non Plan.

In continuation of this Department's Order No. F.1(488)/GA/Estt./DC/06/706 dated 15/03/2021 on the subject cited above and with reference to Finance (Exp.) Department's U.O. No. 130/DS 4 Dt. 11/03/2021 for continuation of temporary posts, sanction of the Pr. Secretary (Revenue)/Divisional Commissioner, Delhi is hereby conveyed for the continuation of the following 489 (377+112) temporary posts in pay scale noted against each plus usual allowance as admissible under the rules for the period 2022-23 for Table No. A, B, C, D, E, F and G in this Order, subject to following conditions:

1. The funds are voted by Delhi Legislative Assembly for the financial year 2022-23.
2. That the expenditure to be met within the sanctioned budget for the financial year 2022-23.
3. The purpose for which these posts were created still exists.
4. That the Admn. Department is to keep a watch on the fact that no post is hit by the ban and any post lying vacant for over a year should not be filled up without prior approval of the Finance Department.
5. That the Admn. Department shall ensure that all the said posts shall be got converted into permanent posts as per Rules, if these temporary posts are more than three years.
6. The Admn. Department shall ensure that posts abolished subsequent to its creation have not been included in this proposal.
7. This continuation is valid for those posts, which are not lying vacant for more than one year since the date of their creation. If any posts remained vacant for more than one year, the Department shall move proposal for abolition of the vacant post(s) by furnishing full details for not filling up the post on priority basis as the abolition order is to be issued within one month of the posts remaining unfilled/held in abeyance for the period of one year.
