All District Magistrates are hereby authorize to incur the expenditure as per allocation of funds after observing all codal formalities.



It may also be noted for compliance that Secretary (Revenue) has allowed following number of Civil Defence Volunteers (CDVs) for each district:-

- (i) 10 Nos of Civil Defence Volunteers as per order dated 11.09.2012 for disaster related activities.
- (ii) 10 (including one reserve) for manning QRTs vehicles and their operation i.e. (2+1 per shift of 8 hours + one reserve) total 10.
- (iii) Wireless operators-3 Nos. (one in each shift) + one Supervisor.

Hence remuneration in respect of only 24 CDVs can be paid out of Disaster Management Cell funds under the above mentioned head.

The above allocation of funds is subject to the following conditions: All codal formalities, as per GFR-2017 etc. shall be completed before incurring expenditure.

- (i) The expenditure shall be incurred only with the prior approval of the authority competent to sanction it in consultation with the Accounts functionaries posted in District/office.
- (ii) All the Revenue Districts shall exercise due diligence while incurring expenditure out of the above allocation as per the prescribed/approved policy, norms and orders/instructions of the Govt. on the subject
- (iii) All the Revenue Districts shall not utilize the above funds for the purpose other than for which the allocation is made.
- (iv) All the Revenue Districts shall furnish monthly expenditure to this office by 5th of the following month & reconciled expenditure by 10th of the following month in respect of the expenditure incurred under the above sub-heads.
