Sir/Madam,

Allocation of funds under MH 2245-02-101-97-98-50 Relief on account of natural calamities was conveyed to all districts with certain conditions vide letter bearing No. F.1/334/Acctt/Budget-Funds/Natural Calamities/2022-23/34-69 Dated:-11-04-22 for incurring expenditure during the current financial year.

It has been observed that the conditions conveyed in the aforesaid letter are not being properly followed in later and sprit. The condition No. II of the above stated letter states that:

"The priority should be given for making payment of remuneration to CDVs, compensation in Mukhyamantri Covid-19 Parivaar Arthik Sahayata Yojana and relief package to farmer for crop damage due to unseasonal rains, in addition to the other COVID related expenditures"
