Public Notice

Whereas, vide notifications no. F.ADM/SE/LAC/2016/506 dated 02.09.2019 the land bearing Khasra No. 6 min(0.672705 Hectare) , Khasra No. 8min(0.1150 Hectare) , Khasra No.13 min(0.316450 Hectare), Khasra No. 40 min(0.2360 Hectare), Khasra No. 156 min(0.9401 Hectare) & Khasra No. 221 min(0.7440 Hectare) of village Nangli Razapur in the Sub Division Defence Colony of District South-East, Delhi were notified under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act 2013(30 of 2013) for infrastructure project i.e. Construction of 3rd Phase of Elevated Road over Barapullaha Nallah starting from Sarai Kale Khan to Mayur Vihar and published by the Collector in the Part I of the NCT of Delhi Gazette, dated 5th September, 2019.

And whereas, the declaration and Summary of Rehabilitation and Resettlement Scheme were published under section 19 of RFCTLARR, Act 2013 in Gazette Notification No. DM/SE/RR/LAC/208 dated 26th August, 2021 and also published in newspapers on 29th August, 2021.

And whereas, a Public notice U/s 21 of RFCTLARR Act 2013 was earlier issued vide no. DM/SE/RR/LAC/292-297 dated 27/11/2021 for intimating to all concerned that the Government intends to take possession of the land mentioned above which is required for "public purpose" and that claims to compensations and rehabilitation and resettlement in above land were made by all interested persons before the collector by appearing personally or by agent or advocate stating the nature of their respective interests in the land. Accordingly, objections were heard on 05.01.2022 in the Conference Hall of the Office of District Magistrate (South-East) .

Now, whereas a corrigendum vide no. DM/SE/LAC/Part-II/ 2021-1801 dt. 01/12/2022 issued for the earlier notification U/s 19 (1) of the RFCTLARR, Act 2013 vide no DM/SE/RR/LAC/ 208 dt 26/08/2021 for land bearing Khasra No. 6min (0.4416, Hectare), Khasra No. 8min (0.1150 Hectare). Khasra No.13min (0.316450 Hectare), Khasra No. 40min (0.202222 Hectare), Khasra No. 156min (0.939634 Hectare), Khasra No. 221min (0.5037 Hectare) of village Nagli Razapur in the Sub Division Defence Colony of District South East for infrastructure project i.e. Construction of 3rd Phase of Elevated Road over Barapullaha Nallah starting from Sarai Kale Khan to Mayur Vihar. The Corrigendum published in the Delhi Gazette on 01/12/2022. In Corrigendum there is no increase in area and ownership is as per Revenue Record.

Now, Nature of interest of owners is not affected due to decrease in area /assets. Further, proceedings under section 21 have already been conducted. However, one more opportunity is being provided to all interested persons to file any objections/claims before the Collector (South-East) on 12.12.2022 at 11:30 AM in the Conference Hall of the Office of District Magistrate (South-East).
