## REJECTION/ CANCELLATION OF CANDIDATURE IN R/O Ms. PINKI YADAV FOR THE POST OF TGT (SANSKRIT) FEMALE UNDER OBC CATGORY POST CODE – 145/17

Whereas Ms. Pinki Yadav applied online application form for the post of TGT Sanskrit (Female), Post Code-145/17 of DSSSB Advt. No. 04/17, under OBC category vide application No.44904478 dated 07/01/2018 wherein the OBC certificate No. 90500000469721 in DSSSB GNCTD was mentioned.

And whereas Ms. Pinki Yadav, (DOB 29.6.1993) Roll No.2520005279 was provisionally nominated & result declared by the DSSSB vide its supplementary result notice No.534 dated 14.10.2019 with remarks against the roll number of the candidate that the candidate has done matriculation in 2007 from Rajasthan, intermediate in 2009 from Rajasthan, B.A. in 2012 from Rajasthan, B.Ed in 2013 from Rajasthan, OBC certificate from Delhi and the dossier of candidate was forwarded by DSSSB with subject to verification of OBC (Delhi) status for appointment to the post of TGT (Sanskrit)-Female, Post Code - 145/17 under OBC category in Directorate of Education, Govt. of NCT of Delhi.

And whereas on preliminary scrutiny of e-dossier of candidate, it was found that OBC certificate bearing no. 90500000469721 of candidate is issued on 24.11.2018 instead of 12.10.2017, which is after cut off date of DSSSB Advt. No. 04/17 i.e. 31.01.2018.

And whereas accordingly a Deficiency Memorandum dated 21.10.2020 regarding OBC/Caste certificate issued after the cut-off date i.e. 31.01.2018 was issued to Pinki Yadav with the direction that submit reply along with supporting document.

And whereas DSSSB vide its advertisement No.04/2017, for the above said post, it is stated in condition of para 5 sub para (ii) " candidate who wish to be considered against reserved vacancies and / or to seek age relaxation, must be in possession of relevant certificates(SC/ST/OBC/Non Creamy layer / PH/ Education / Experience etc.) issued by the competent / notified authority (in prescribed format) on or before the cutoff date (closing date of advertisement) otherwise their claim for any category will not be entrained and their applications will be considered against Un-reserved(UR) category vacancies, if eligible otherwise.

And whereas candidate failed to submit valid OBC(Delhi) certificate issued on or before cut off date i.e 31.01.2018 and it is found from the dossier that candidate has submitted the false information regarding date of issuance of OBC (Delhi) certificate No. 90500000469721 during filling online application form in DSSSB therefore application form submitted successfully. However, the candidate on physical verification of OBC certificate produced OBC certificate no. 90500000469721 issued on 24.11.2018 which is after cut-off date i.e. 31.01.2018.

And whereas the matter of candidate was considered in this Directorate and the candidature of the candidate has been cancelled by the Competent Authority as the OBC caste certificate of the candidate found to be issued on 24.11.2018 which is after cut cut off date i.e. 31.01.2018.

Therefore, in view of the above facts and circumstances, the candidature of Ms. Pinki Yadav (DOB 29.06.1993) Roll No. 2520005279 for the post of TGT Sanskrit Female under OBC category is hereby rejected and her e-dossier returned to the DSSSB, GNCTD.
