ORDER

Cancellation of Candidature for the post of Drawing Teacher-91/17

Whereas, Sh. Brijender Kumar, DOB 07.07.1989, Roll No. 110809100034 was nominated by the DSSSB vide letter No. F.1 (381)/DSSSB/P&P/2017/4650 dated 21.01.2021 for appointment to the post of Drawing Teacher, under Post Code -91/17 in Directorate of Education, Govt. of NCT of Delhi.

Whereas, during the course of document verification of the candidate's dossier, the scheduled caste certificate uploaded in e-dossier and submitted at the time of document verification were issued on 27.03.2018 and 07.04.2018 respectively, both were found issued after the cut of date i.e. 31.01.2018. In this regard deficiency memos were issued to the candidate on 29.11.2021, 24.12.2021, 24.01.2021 and a final opportunity also given on 11.03.2022 to provide the Scheduled Caste Certificate before the cut of date i.e. 31.01.2018 as per advt. no. 04/17 dated 20.12.2017.

Whereas, the reply of deficiency memo has been submitted by the candidate on 21.03.2022 that he has caste certificates which were issued on 27.03.2018 and 07.04.2018. He has also stated that his father's caste certificate was issued on 01.02.2021 and he is working in Jawahar Navodya Vidhayala, J.P Nagar, Uttar Pradesh as a Misc. Art Teacher.


Whereas, it had been clearly mentioned in Advertisement No. 04/17 dated 20.12.2017 The candidates must read the INSTRUCTIONS FOR APPLYING ONLINE carefully, which are available on the website of the Board, before filling up Online Application Form for the post(s) concerned. The educational qualification, age, experience etc. as stipulated in advertisement shall be determined as on the closing date i.e. 31.01.2018 of submission of application.

Whereas, evidently the candidate does not meet the mandatory conditions/provisions as on the cutoff date i.e. 31.01.2018 as laid down in advt. no. 04/17 dated 20.12.2017 hence, his candidature can't be considered for appointment against Drawing Teacher, under post code-91/17.

Therefore, the Offer of Appointment No. DE.4(3)/DRC/E-IV/Drawing Tr./2019/6150 dated 11/10/2021 issued in r/o Sh. Brijendra Kumar. DOB-07.07.1989, Roll No. 110809100034 is hereby withdrawn and his candidature stands cancelled forthwith, as the candidate does not fulfill the eligibility criteria on cutoff date i.e. 31.01.2018, as preset in said advertisement.


