Consequent upon selection through Delhi Subordinate Services Selection Board to the post of LECTURER SANSKRIT(MALE) and with the Prior approval of the Competent Authority, the candidate is hereby appointed purely on Temporary basis to the post of LECTURER SANSKRIT(MALE) vide post code 76/20 in the Pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4800 (Pre-revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by him/her. Further, the candidate has sought exemption from Medical examination by virtue of being already in Government Service.
