Cancellation of Candidature for the post of Assistant Teacher (Primary)-89/17


Whereas, Sh. Pankaj, D.O.B. 20/10//1993, Roll No. 110508900520 was nominated by the DSSSB for the post of Assistant Teacher (Primary) against post code 89/17 in Directorate of Education, Govt. of NCT of Delhi vide result notice no. 1356 dated 20/09/2021 and accordingly an offer of Appointment was issued to him vide No. DE.4(10)/DRC/E-IV/PRT/Part file-I/2019/157 dated 07/01/2022

After document verification, a medical letter was issued to Sh. Pankaj for his medical examination vide letter no. F.DE4(10)/DRC/E-IV/PRT/Pt.File/2019/97 dated 31/01/2022 but he did not report in the allotted hospital. The Incharge Medical Board, DDU Hospital vide letter dated 03/06/2022 has reported as "he has not reported till date for medical examination". Further, the candidate was directed to appear in DR Cell, E-IV, Dte. of Education vide this office letter dated 10/06/2022 & 20/06/2022 so that re-medical letter may be issued to the candidate but the candidate did not appear in Dte. of Education till date.

Therefore, the offer of appointment No. DE.4(10)/DRC/E-IV/PRT/Part file-I/2019/157 dated 07/01/2022 in r/o Sh. Pankaj, D.O.B. 20/10//1993, Roll No. 110508900520 to the post of Assistant Teacher (Primary), against post code 89/17, is hereby withdrawn and the candidature stands cancelled.


