## ORDER

## Cancellation of offer of Appointment and candidature to the post of PGT(SOCIOLOGY) FEMALE, POST Code 65/20

Whereas, Ms. JASMINE, D.O.B. 17-08-1996, Roll No. 11260200010 has been nominated by the DSSSB to the post of PGT(SOCIOLOGY)-FEMALE against Post Code 65/20 vide Result Notice No. 1378 dated 05/10/2021 in the Directorate of Education, Govt. of NCT of Delhi.

Whereas, the candidate was appointed/posted at Bankner-GGSSS-1310049 vide Order No:DE.2(40)/DRC(E-II)/PGT(SOCIOLOGY)/FEMALE/2021/70 dated: 22/02/2022 (Posting ID: 20220024), with the direction to join her place of posting latest by 21/03/2022.

Whereas, she sought extension of joining and the same has been granted vide 1<sup>st</sup> extension order No:DE.2(40)/DRC(E-II)/PGT(SOCIOLOGY)/FEMALE/2021/322-323 dated: 07/04/2022 to join till 20/04/2022 and 2<sup>nd</sup> extension order no. 737 dated: 02/05/2022 to join till 20/05/2022 and Notice of joining vide order No:DE.2(40)/DRC(E-II)/PGT(SOCIOLOGY)/FEMALE/2021/1133 dated: 30.05.2022 to join till 14/06/2022 and Final Notice (last opportunity) of joining vide order No:DE.2(40)/DRC(E-II)/PGT(SOCIOLOGY)/FEMALE/2021/1565 dated 02.08.2022 to join till 07/08/2022.

Whereas, it is found that the candidate has neither joined her allotted school nor sought any further extension for joining till date.

As per DOPT OM no. 35016/2/93-Estt.(D) dated 09.08.1995, the following has been mentioned:

"An offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however with the specified period a request is received from the candidate for extension of time, It may be considered by the ministry/Department but extension beyond 3 months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum period of 6 months from the date of issue of original offer of an appointment". An offer of appointment would lapse automatically after the expiry of 6 months from the date of issue of the original offer of appointment.

Therefore it is evident that the candidate is no longer interested in joining the above mentioned post.
