Whereas, **Shri ROHIT YADAV**, D.O.B. 07.09.1995, Roll No. 111307000038 has been nominated by the DSSSB for the post of PGT (Computer Science) Male against Post Code 70/20 vide letter no.F.4(276)/DSSSB/P&P/2019/6271 dated 27.12.2021 vide Result Notice No. 817 dated 07.12.2021 and accordingly an Offer of Appointment was issued to him vide this Directorate Memorandum No.F.123/669-6670 dated 19.04.2022, the second opportunity was given to him vide reminder-I Memorandum No.F.125/1190-91 dated 01.06.2022 and Final Opportunity vide Memorandum No.F.123/1228 dated 23.06.2022.

Cancellation of Offer of Appointment to the post of PGT (Computer Science) Male

Whereas, **Shri SAHIL MANCHANDA**, D.O.B. 10.01.1993, Roll No. 121107000077 has been nominated by the DSSSB for the post of PGT (Computer Science) Male against Post Code 70/20 vide letter no.F.4(276)/DSSSB/P&P/2019/6271 dated 27.12.2021 vide Result Notice No. 817 dated 07.12.2021 and accordingly an Offer of Appointment was issued to him vide this Directorate Memorandum No.F.125/661-662 dated 19.04.2022 for verification of documents on 05.05.2022.

1. And Whereas, on subsequent verification of documents on the said schedule, a deficiency memo was issued to Shri SAHIL MANCHANDA vide which he was asked to submit the requisite documents. The candidate was given 15 days to submit the reply of the said deficiency memo but he did not turn up. Thereafter he was again asked to submit the required documents vide deficiency memo reminder-1 no.
