Whereas, **Shri RAVINDER KUMAR**, D.O.B. 09.09.1980, Roll No. 11250400169 has been nominated by the DSSSB for the post of PGT (Commerce) Male against Post Code 23/20 vide letter no.F.4(304)/DSSSB/P&P/2019/299 dated 18.02.2022 vide Result Notice No. 824 dated 12.01.2022. During the course of initial scrutiny of documents, it was found that the candidate has completed his M.Com. degree on 14.08.2019 from IGNOU & B.Ed. degree on 27.12.2019 from CCSU, Meerut i.e. completed both degrees in the same session. Consequently, vide letter no. F.No.DE.2(66)/DRC(E-II)/PGT(Commerce)/Male/2021/1071 dated 12.05.2022 a deficiency memo in this regard was issued to the candidate. The candidate replied in response to the aforesaid deficiency memorandum.

And, whereas, Distance Education Council, IGNOU vide his letter no. F.No.DEC/Notification/40.5.1.5/2012/15983-16229 dated 01.11.2012 under subject "Policy on pursuing two or more programmes simultaneously in various combinations" has stated that: "A student can pursue two programmes simultaneously through distance or combination of distance and regular modes from the same or different University/Institution(s) in various combinations, viz..

1. One Degree and one Diploma/ Post Graduate Diploma/ Certificate
2. One Post Graduate Diploma and one Diploma/Certificate
3. One Diploma and one Certificate
4. Two Post Graduate Diplomas
5. Two Diplomas
6. Two Certificates."

Therefore, in view of the facts and circumstances as above and since the candidate has acquired two essential qualification degrees at the same time which is not covered under the above said notification dated 01.11.2012 issued by IGNOU, the candidature in respect of **Shri RAVINDER KUMAR** for the post of PGT (Commerce) is hereby **cancelled** and his dossier returned to the DSSSB.


