**ORDER**

**Cancellation of Offer of Appointment to the post of PGT (Commerce) Male**  
**Post Code 23/20**

Whereas, **Shri SHIV KANT**, D.O.B. 07.01.1981, Roll No. 11160400080 has been nominated by the DSSSB for the post of PGT (Commerce) Male against Post Code 23/20 vide letter no.F.4(304)/DSSSB/P&P/2019/299 dated 18.02.2022 vide Result Notice No. 824 dated 12.01.2022.

And whereas, the candidate had applied under DCF as sub-category. Vide Offer of Appointment No.F.DE.2(66)/DRC(E-II)/PGT(Commerce)/Male/2021/1031-32 dated 06.05.2022, the candidate was called for verification of documents on 20.05.2022 at 11:30 A.M.. At the time of verification of documents, the candidate submitted working experience of Kendriya Vidyalaya.

And whereas, since the candidate was seeking age relaxation under DCF category, while he has submitted working experience of Kendriya Vidyalaya, therefore, vide deficiency memo no. F.No.DE.2(66)/DRC(E-II)/PGT(Commerce)/Male/2021/1198 dated 03.06.2022 he was asked to submit working experience which substantiate his claim for DCF sub-category resulting in age-relaxation.


And, whereas, the Recruitment Rules for the post of PGT (Commerce)/ DSSSB define the "Extent of age concession" of category "*Departmental candidate with at least three years continuous service in Govt. of NCT of Delhi/its local or autonomous bodies*" mentioned at S.No. 6 of table at para 6 i.e. "AGE RELAXATION" of the above mentioned advertisement, as below:-

Therefore, in view of the facts and circumstances as above and since the candidate is **overage** as on the cut-off date i.e. 22.02.2020 of the said advertisement, hence, the candidature in respect of **Shri SHIV KANT** for the post of PGT (Commerce) is hereby **cancelled** and his dossier returned to the DSSSB.
