The concerned Municipal Authority may relieve the concerned teacher to join the promotional post latest by 19/01/2023(after submission of the said certificate by the teacher) after ensuring that there is no vigilance case /departmental enquiry pending / no penalty in operation against the teachers at any level at the time of relieving to assume the promotional post. It should be specifically/ clearly mentioned in the relieving order of the promoted teachers that no vigilance case is contemplated/ pending against him/her at any level. If any discrepancy, the concerned DDE district may contact in E-III Branch, Directorate of Education, GNCTD. This issues with the prior approval of the Competent Authority.
