ORDER

Cancellation of Offer of Appointment to the post of PGT (Maths) Female
Post Code 29/20


Whereas, **Ms. PRIYANKA KATARIYA**, D.O.B. **01/07/1994**, Roll No. **111102900050** has been nominated by the DSSSB for the post of PGT (Maths) Female against Post Code 29/20 vide letter no. F.4(290)/DSSSB/P&P/2019/6204 dated 16.12.2021 vide Result Notice No. 820 dated 07.12.2021 and accordingly during preliminary scrutiny of document received from DSSSB, some deficiencies were observed and the said candidate was advised to submit the requisite documents vide this Directorate Deficiency Memorandum No. 657 dated 13/05/2022, the second opportunity to submit the requisite deficiency document was given to her vide reminder-I Deficiency Memorandum No. 1109 dated 24/05/2022 and Final Opportunity vide Deficiency Memorandum 2737 dated 04/10/2022.

2. And Whereas, **Ms. PRIYANKA KATARIYA** did not give her representation regarding the said deficiency in this Directorate issued to her vide letter of even no. dated 13/05/2022, Reminder-I of even no. dated 24/05/2022 and Final Reminder of even no. dated 04/10/2022 has neither intimated any reason to this Directorate for not responding to the deficiency memorandum.
3. As per DoPT Office Memorandum NO. 35016/2/93-Estt.(D) dated 09/08/95 wherein as per para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of six months from the date of issue of the original offer of an appointment". **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**

Therefore, In view of above, the candidature in respect of **Ms. PRIYANKA KATARIYA**, D.O.B. **01/07/1994**, Roll No. **111102900050** is hereby cancelled and her dossier returned to the DSSSB.
