ORDER


WHEREAS Sh. Rajesh Kumar, Cook, DOB-21/07/1970 of Department of Social Welfare, GNCT of Delhi was promoted to the post of Laboratory Assistant in Directorate of Education, GNCT of Delhi vide order No. DE.4(8)/(23)/E-IV/Lab.Asstt.(Promotion)/2020/1193-1202 dated 03/09/2021 on ad-hoc basis.

AND WHEREAS during the course of verification of documents Sh. Rajesh Kumar submitted duplicate copy of matriculation mark sheet issued on 15.09.2020 for the session October, 2019 but as per criteria of promotion cutoff date of acquiring minimum education qualification by an official has been kept on or before **31.12.2019**.

AND WHEREAS for clarification regarding date of declaration of result we sent letters to the NIOS on dated 03/02/2022 and dated 21/07/2022. Further, NIOS has reply vide letter no. F.7-103/2022/NIOS/Eval./M&M/332 dated 22/08/2022 that "as per record Oct., 2019 Secondary School Examination declaration date is 19/05/2020" which is out of cutoff date i.e. 31.12.2019 for acquiring minimum educational qualification.

In view of above, the promotion order No. DE.4(8)/(23)/E-IV/Lab.Asstt.(Promotion)/2020/1193-1202 dated 03/09/2021 in respect of Sh. Rajesh Kumar, Cook, DOB-21/07/1970 of Department of Social Welfare, GNCT of Delhi is hereby cancelled/withdrawn with immediate effect.
