In exercise of powers conferred under Rule 13(3) of Delegation of Financial Powers Rules, 1978 and further in supersession of all previous orders regarding delegation of financial powers, the undersigned is pleased to authorize Special Commissioner, Food, Supplies and Consumer Affairs to exercise all the financial powers of HOD in r/o Department of Food, Supplies and Consumer Affairs, as per delegated to HOD by the Finance Department vide their OM No. F 20/08/2019/AC/JSfina/2575-2674 dated 07/08/2019. Further, in case of vacant post of Special Commissioner (F&S), the financial powers of HOD as per FD OM dated 07/08/2019 referred above shall be exercised by the Additional Commissioner, Food, Supply and Consumer Affairs. Financial powers delegated to Administrative Secretary by FD vide above mentioned OM shall continue to be exercised by Secretary-cum-Commissioner, F&S

The above delegation of financial powers is subject to completion of all codal formalities as per the Rules applicable in each case. The Officer will exercise these powers subject to such orders/instructions as may be issued from time to time by the Government of India/Government of NCT of Delhi and after vetting of the proposals by the Accounts functionary of the Department.


