1. They shall be required to deposit earnest money with each application for tender, as per terms and conditions of the Notice Inviting Tenders.
2. Security deposit will be recovered from their running bills in accordance with the rules enforce from time to time.
3. They shall employ the required technical staff, tools & plants as per terms and conditions of each contract/agreement.
4. They shall abide by the terms and conditions of the NIT/Contract/Agreement.
5. They shall not modify the existing partnership or enter into any fresh partnership without prior approval of the enlistment authority. Such proposal if any shall be submitted in advance giving full details of the intended partnership/sole proprietorship along with the draft partnership deed/affidavit. Without prior approval of the enlistment authority, the contractor/firm shall be liable to remove from the approved list of contractors.
6. They shall not be permitted to tender for works in Irrigation and Flood Control Department of Delhi if his relative is posted as Divisional Accountant or an officer between the grades of Superintending Engineer and Junior Engineer (Both inclusive). They shall also intimate the names of relatives who are working in Irrigation and Flood Control Department. Any breach of the conditions by contractors shall be liable to remove from the approved list of contractors of the department.
7. The contractors shall be required to apply for revalidation of their enlistment in the prescribe form along with all required documents before the date of expiry of his enlistment.
8. They are required to secure works in the department. In case they fail to secure any work of specified magnitude during the period of enlistment/revalidation, the enlistment of the contractor is liable to cancel.
9. They shall also intimate the change in their address (Registered office/Head Office) if any, in future and in case they fail to intimate such to the department, their name would be removed from the approved list of the contractor.
10. They shall be bound by the enlistment rules of the department as amended from time to time.
