For all other online services of the Electrical Inspectorate, the delivery timeline shall be followed as mentioned on e-district portal of GNCTD.

The verification letter in respect of the Electrical Contractor Licenses granted by the Electrical Inspectorate shall be issued within fifteen (15) working days from receipt of the request. Further, in the other offline services the following are the SOPs and time line for disposal:-
