ORDER

This order will dispose-off the appeal filed by Shri S.M. Qamar in respect of ID 16687(Appeal No. 2060), ID No.16711(Appeal No.2061), ID No.16688(Appeal No.2062), ID No.16735(Appeal No.2080), ID No.16736(Appeal No. 2079), ID No.16755(Appeal No.2082), Sh. Sultan Chowdhry & Sh. S.M. Qamar ID No.16754(Appeal No. 2081 & 2087) and Mohd Ahmed in respect of RTI I.D. No.16784(Appeal No.2089) & ID No.16810(Appeal No.2088).

5. Case called. During the hearing the PIO stated that since information is third party reply has been given accordingly. Appellant submitted that rent receipt is attached for year 1969. The PIO informed that subsequently the property was auctioned by department in 1973 to Sh. Riaj Ahmed and Jawahar bi.

The PIO informed that this reply has already been given to the appellant in multiple and repeated RTIs on same subject, filed in different name viz. Sh. Mohd Ahmed his father & also friend Sultan Chowdhry.

Since long time all the 9 appeals listed today pertain to the same subject filed by appellants who are related parties.



The PIO EP Cell is directed to give a fresh reply common to all these RTI Appeals pertaining to the auctions/process matter of property 2506-2507 Ballimaran, within the provision of RTI Act within 15 days.

No merit in appeal on the information given by Admn. Branch. Dismissed to that extent.

In light of the above, this appeal is disposed accordingly.

However, if aggrieved with this decision he may file an appeal before the second Appellate Authority within 90 days of receipt of this order.
