ORDER

This order will dispose-off the appeal filed by Shri S.M. Qamar in respect of ID. No. 16879(Appeal No. 2109), ID No.16899 (Appeal No.2110), ID.No.16900(Appeal No.2112), ID.No.16958(Appeal No.2120), ID No.16918(Appeal No. 2121), ID No.16969(Appeal No.2122),ID No.16981(Appeal No. 2127),ID. No.17018 (Appeal No.2130) & ID No.17004 (Appeal No.2131) and RTI ID. No.16978 (Apeel No.2119) in respect of Shri Mohd. Qamar.

1. Sh. S.M. Qamar, Appellant present on 12.09.2022. Sh. Mohd. Qamar was called for appeal No. 2119 RTI ID. No. 16978 but Sh. S.M. Qamar was present stating that he himself is also Mohd. Qamar and sometimes file RTI in the name of Mohd. Qamar also.
2. Present Sh. Mohd. Irfan, Section Officer for SPIO/DS (EP) and Shri Sunil Bala Sadawarti, Section Officer present for DS/PIO (Admn).
3. During the hearing the PIO submitted that all the appeals pertains to the same property for which replies have already be given that Property No. 2506-2507, Baradari, Ballimaran is a third party information & cannot be given. Earlier also many appeals on the same matter have been disposed on 02.06.2022 vide order No. PS/S.S/L&B/2060/2022/Appeal/1661-66 dated 13.06.2022. The appellant has also approached the CIC in lInd appeal and in one appeal CIC has directed the deptt on 08.09.2022 to give reply in 30 days but the order of CIC is awaited.
4. The Compliance of CIC direction by the department in respect of these properties shall also meet the requirement of the reply in these appeals.
