1. Brief facts of the complaint

1.1 Sh. Anurag Sharma has filed a grievance petition before Public Grievances Commission on 30.09.2020 aggrieved by inaction on the part of BSES YPL in not releasing the pension and salary of his father.

2. Facts emerged during the proceedings.

2.1 Manager(Pension Trust), DVB ETBF-2002 stated that the complainant has furnished the required documents with regard to release of PF amount. The same is being examined/processed in the concerned section. He assured to release the amount of

Provident Fund in respect of the complainant's father within 10 (ten) days positively.

2.2 Shri Pawan Kumar Mahur, Sr.Manager(Legal) BSES Yamuna Power Limited stated that the matter has been re-examined in detail as per rules and in the light of the judgment of Hon'ble Supreme Court of India mentioned in earlier order. During the proceedings, it is reiterated that BSES Yamuna Power Limited is not liable to make payment for any pensionary or terminal benefits in favour of Late Shri R D Sharma, and the appropriate authority for making the payments in this regard is the Pension Trust (if any amount is due and payable).

3. Directions

3.1 Manager (Pension Trust) DVB ETBF PensionTrust-2002, Rajghat is requested to ensure release of PF, as assured by him, in respect of the complainant's father, within ten (10) days positively.

3.2 With regard to other outstanding terminal benefits in respect of late Shri R.D. Sharma, the complainant is advised to approach appropriate forum or seek legal remedy for release of the same.

3.3 With the above observations, the case of the complainant stands disposed of.
