1. Brief facts of the case

1.1 Sh. Dinesh Chandra Joshi has filed a grievance petition before Public Grievances Commission, aggrieved by non-payment of Composite Transfer Grant on retirement from Government Service. The complainant in his petition stated that he superannuated from Delhi Transco Limited, GNCTD, Kotla Road, New Delhi on 31.10.2018 as Section Officer. He had submitted number of applications regarding granting of Composite Transfer Grant as per TA Rules but till date neither any acknowledgement nor any reply has been received from Delhi Transco Ltd. He had sent a letter to General Manager(HR), Delhi Transco Limited, Director(HR), DTL, CMD, DTL on 30.4.2019, 01.6.2020 and 27.08.2020 respectively but no action has been taken so far.

The complainant further stated that he is entitled for the benefit of Composite Transfer Grant as per the Rules/Guidelines issued by Department of Expenditure, Ministry of Finance, Govt.of India dated 13.07.2017 which is also endorsed by Finance Department, GNCTD on 19.07.2017.

2. Facts emerged during the proceedings.

- 2.1 Shri N.K. Sharma, Dy.General Manager(HR), Delhi Transco Limited filed an action taken report. As per report "The matter of implementation of composite transfer grant as per DoPT was placed before the Board of Directors of DTL. The same has been approved by the BoD, DTL.(copy enclosed). As per the approval of the Board, the case of Sh.D.C.Joshi was placed before the Competent Authority and the approval of the same has also been obtained. Accordingly, the main file for the payment of Composite Transfer Grant and charges of transportation of personnel effects has been sent to Finance Wing for the release of payment to Sh.D.C. Joshi."
- 2.2 Shri N.K. Sharma, Dy.General Manager(HR), Delhi Transco Limited assured the complainant as well as the Commission that payment of Composite Transfer Grant would be released, as per rules, within ten (10) days positively,
- 2.3 The complainant is satisfied over action taken by the respondent department.

3. Directions:

- 3.1 Chairman-cum-Managing Director, Delhi Transco Limited, is requested to look into the matter at his level for expeditious redressal of grievances of the complainant.
- 3.2 Shri N.K. Sharma, Dy.GM(HR), Delhi Transo Limited is requested to ensure that payment of Composite Transfer Grant is released to the complainant within ten (10) days positively, as assured by him. A documentary proof in this regard be furnished to the Commission after release of outstanding dues of the complainant.
- 3.3 The complainant is advised to inform the Commission in writing as soon as he receives the outstanding amount of Composite Transfer Grant from Delhi Transco Limited. In case he does not receive the same within ten days, he is at liberty to approach the Commission.
- 3.4 In view of the above, the case stands disposed of in the Commission.
