### 1. Brief facts of the complaint

1.1 Sh. G.S. Flora has filed a grievance petition before Public Grievances Commission, aggrieved by non payment of MACP benefits in the Grade Pay of Rs.6600/- in Pay Band 3 (Rs.15,600 – 39,100/-) under sixth CPC vide Department of Training & Technical Education order dated 30.09.2020. He retired as Vice Principal on 31.12.2015 from ITI Nand Nagari, Delhi.

## 2. Relevant facts emerging during the hearing

2.1 Sh. Sanjeev Sehgal, C.I./JTA, Dte. of TTE, GNCT of Delhi filed status report dated 04.03.2022 stating therein that:-

"In reference to para 2.3 of the Order dated 09.02.2022 issued by the Hon'ble Commission, it is informed that the complainant Sh. G.S. Flora was promoted to the post of Vice Principal vide DTTE order dated 26.12.2012 and was granted financial benefits of 2<sup>nd</sup> MACP w.e.f. 24.07.2015 in the Grade Pay of Rs.6600/- in Level 11, vide DTTE order dated 30.09.2020 (copy enclosed."

- 2.2 Sh. Om Prakash, Section Officer, Industrial Training Institute (ITI), filed Revision Authority for Central Civil Pensions, whereby, pension in respect of the complainant has been revised after grant of 2<sup>nd</sup> MACP.
- 2.3 Ms. Meenakshi Singh, AAO, PAO No. VIII, GNCT of Delhi filed a letter dated 28.02.2022 from Sh. Satvinder Singh, Pay & Accounts Officer-VIII, GNCT of Delhi to Pay & Accounts Officer, Central Pension Accounting Office, Govt. of India, stating therein that:-

"Office of PAO-8 has already issued authority for releasing the difference amount of commuted value pension amounting to Rs.42,085/- on dated 14.01.2022 vide No. 680371502389/4169442/A-2 diary No.PR122000851."

2.4 The complainant stated that his grievances has been redressed by the department and the due amount will be credited by the concerned bank. He has, however, submitted that the pending amount shall be credited expeditiously if the PAO-8 and the department of TTE coordinate with the concerned bank regarding revision of pension w.e.f. year 2016 and differential commuted value pension amounting to Rs.42,085/-.

#### 3. <u>Directions of the PGC</u>

- 3.1 The Pay & Accounts Officer-8, GNCT of Delhi and Principal, ITI Nand Nagari, GNCT of Delhi shall coordinate with the concerned bank for crediting of the due amount in the complainant's bank account at their own level and apprise the complainant as well as the Commission of the outcome of this grievance. Further, the complainant is at liberty to approach the Department of Training & Technical Education as well as the Commission in case his grievance is not satisfactorily resolved by the department.
- 3.2 In view of the above directions, the case stands disposed of in the Commission.

3.3 The Commission appreciates the efforts put in by the respondent department in processing the case as well as for release of outstanding legitimate dues in respect of the complainant.
