1. Brief facts of the complaint

- 1.1 Sh. H.B.S. Rana, who retired as Vice Principal from Harcourt Butler Senior Secondary School, Mandir Marg, New Delhi 110001, filed a grievance petition before Public Grievances Commission against the Dte. of Education, aggrieved by:-
- (i) Non-addition of the Family Pensioner/Spouse name Mrs. Raj Kumari.
- (ii) Correction in the Date of Birth of the Family Pensioner/Spouse 15.09.1943. Further, the concerned PAO XV has not issued revised PPO (Pension Payment Order) to him till date.

2. Relevant facts emerging during the hearing

- 2.1 Sh. Atul Arya, Head Clerk, Harcourt Butler Senior Secondary School, Mandir Marg, New Delhi 110001 filed a Status Report, stating therein that:-
- "1. A request has been forwarded vide letter dated 21.05.2022 to Pay & Accounts Officer, PAO-XV to add the name of wife of Sh. HBS Rana in the pension records alongwith copy to Canara Bank and DDE (Zone-26), copy attached.
- 2. Sh. HBS Rana was also informed about the same and copy was forwarded to him as a matter of record.
- 3. A request was also forwarded by Sr.A.O., Distt. Central/ND to Pay & Accounts Officer, PAO-XV vide letter dated 17.01.2022 for addition of name (copy attached).

The matter pertains to the Deptt. of Education as well as Pension Cell for the same and no reply has been received in the school office till date, either from Sh. HBS Rana and the Deptt. of Education for rectification of the matter."

2.2 The complainant submitted that an e-mail was sent by the concerned Canara Bank, attaching therein a statement from Senior Manager, Centralized Pension Processing Centre, Canara Bank, Bangalore. It is stated in the mail that the name of the wife of Sh. HBS Rana has been updated in the pension records and will be reflected in the next month pension slip. He further expressed satisfaction with the action taken by the Education Department as well as the concerned PAO-XV for taking necessary action in the matter for redressal of his grievance.

3. Directions of the PGC

- 3.1 Keeping in view the submissions made by the departmental representative and the satisfaction expressed by the complainant, the case stands disposed of in the Commission.
- 3.2 The Commission appreciates the efforts put in by the respondent department for redressal of the grievances of the complainant.
