Brief facts of the case

1.1 A grievance petition has been received from Insta Digital Media Pvt. Ltd. in Public Grievances Commission, with regard to supply of dirty water in C-161, Mayapuri Industrial Area, Phase-II, New Delhi-110064. In this connection, a complaint #DJB000191458 has been registered with Delhi Jal Board on 28th April, 2022 which remains unresolved.

2. Facts emerged during the proceedings.

2.1 An action taken report has been filed on behalf of Sh. Rakesh Kumar Garg, Executive Engineer (M)-28, Delhi Jal Board, GNCT of Delhi, Office of the Executive Engineer (M)-28, Beri Wala Bagh, Subhash Nagar, New Delhi-110064. As per report:-
