## 1. Brief facts of the case

1.1 Shri R.K. Khanna has filed a grievance petition before Public Grievances Commission, aggrieved by no supply of drinking water for the last two months in the area of South Extension Part-2 whereas adjoining areas like Kotla Mubarak Pur are receiving water supply throughout the day.

# 2. Facts emerged during the proceedings.

- 2.1 The hearing in the matter could not be held on 11.07.2022 and 13.07.2022 and was rescheduled for 20.07.2022.
- 2.2 Shri Sawant Singh, Executive Engineer(M)-42, Delhi Jal Board, GNCT of Delhi, filed an action taken report. As per report "Water supply was running at low pressure and short due to rationalisation as there was fall in pond level at Wazirabad. The area of South Extension Part-II lies at the tail end of the distribution system. Hence,

sometimes, water problem arises temporarily. But water tankers are supplied on demand whenever required by the residents. Now the water supply is turning normal. "

2.3 The complainant is not present.
