**Order under Para 2(B) of the PGC Resolution No F.4/14/94-AR dated 25.9.97**

**1. Brief facts of the complaint**

Sh. Rajender has filed a grievance in PGC regarding non release of certain pensionary benefits and arrears of 7<sup>th</sup> CPC after retirement on 31.05.2016, from Shahadara South Zone, EDMC.

**2. Proceedings in the Public Grievances Commission**

The PGC has convened four hearings in the matter and in the hearing held on 10.0.2022 the following are present :

**3. Relevant facts that emerged during the hearing**

3.1 Shri G.R.Sharma, ASO, Shahadara South Zone, EDMC is present in the hearing but did not submit any status report / ATR. He was advised to submit an ATR duly signed by the concerned officer from the zone. Consequently, a status report dated 10.08.2022 signed by the Administrative Officer, Shahadara South Zone is received in the Commission on 11.08.2022, stating that :

***“No carelessness until there is a cure. Wear Mask, follow physical distancing & maintain hand hygiene.”***

"It is submitted that duplicate service book of the employee was created / prepared with the approval of Deputy Commissioner, Shahadara South Zone. File for GIS payment was moved to concerned department who passed the GIS payment of Rs. 8143/- on 05.07.2022. The payment shall be made on availability of funds.

In compliance to office order dated 09.08.2011 of Vigilance Department, four increments of the employee were stopped with cumulative effect. Accordingly, he is not entitled for arrear of these four increments. The department has re-fixed the employee's pay according to 7<sup>th</sup> CPC on 01.01.2016. Leave encashment difference arrear of Rs. 37170/- has been passed today i.e. on 10.08.2022 as per 7<sup>th</sup> CPC."

#### **4. Recommendations of the PGC**

Ms Vandana Rao, Deputy Commissioner, Shahadara South Zone is advised to direct the concerned officers to release the payments of the complainant, for which the bills have been passed. She is further advised to ensure that the complainant's pension is revised as per his revised pay, according to 7<sup>th</sup> CPC.

With the above directions the matter stands closed at the level of the Commission.
