#### 1. Brief facts of the case

1.1 Shri Aman Kumar has filed a grievance petition before Public Grievances Commission, aggrieved by non-release of water connection by Delhi Jal Board.

- 2.1 The hearing in the matter could not be held on 12.07.2022 and 14.07.2022 and was rescheduled for 21.07.2022.
