As per report, "*The work for replacement of old sewer line has been taken up as remedial measure to resolve water contamination problem. The same has been completed and road restoration will be done by MCD for which payment has already been made. However, work to trace out the source of contamination and rectification was done and now water supply is clean and clear."*

2.2 The complainant present is totally satisfied with the action taken by the respondent department. He thanked Delhi Jal Board and the Commission for expeditous redressal of the grievances.
