**1. Brief facts of the complaint**

"In the matter mentioned above, it is stated that this work is being carried out by I & FC Department and MCD has not carried out any maintenance or development activities on this road. "

He further stated that an inspection was also carried out by the officers of Rohini Zone alongwith Supdtg. Engineer and Ex. Engineer of Irrigation & Flood Control Department under the directions of the Deputy Commissioner, Rohini Zone and now the repair work is going on.

**4. Recommendations of the PGC**

As the repair / construction work of road is being carried out by the Irrigation & Flood Control Department and once the work is complete the grievance of the complainant will be addressed, the matter stands closed at the level of the Commission.
