**Order under Para 2(B) of the PGC Resolution No F.4/14/94-AR**

**1. Brief facts of the complaint**

Sh. Subhash Chand Chauhan, Ex. Engineer (Retired) has filed a grievance in PGC regarding payment of salary for the period 22.08.2020 to 22.02.2021 (6 months) when he worked as Consultant in the O/o Engineer –in- Chief, PWD, Delhi.

**2. Proceedings in the Public Grievances Commission**

The PGC has convened two hearings in the matter and in the hearing held on 10.08.2022, the following are present :

**3. Relevant facts that emerged during the hearing**

3.1 Sh. Deepak Sharma, O.S. and Sh. Sanjeev Mathur, AAO, PWD are present in the hearing and submitted a status report stating that :

“It is stated that payment of extended period of already engaged consultant will be made as soon as the necessary approval is received from Hon'ble L.G. of Delhi through Principal Secretary (PWD).

***“No carelessness until there is a cure.  
Wear Mask, follow physical distancing & maintain hand hygiene.”***

It is further stated that payment of pending wages of engaged consultants shall be made within 15 days, once the required approval received from the Hon'ble L.G. Office."

3.2 During the discussions they informed that the file is pending in the Pr. Secretary, PWD's office and the matter is being pursued at their level on regular basis.

**4. Recommendations of the PGC :**

4.1 Engineer-in-chief, PWD is advised to pursue the matter with the concerned higher authorities, get the file cleared and ensure that pending payments are made to the complainant. Once the payment is made to the complainant a status report be submitted to this Commission, for information.

4.2 Pr. Secretary, PWD is requested to forward the file for approval of the Competent Authority, at the earliest possible.

With the above directions the matter stands closed at the level of the Commission.
