1. Brief facts of the case

The complainant Dr. Kulen Das has filed a grievance in the Commission stating that he retired from regular service as CMO (SAG) on 29.2.2016 from the Department of Health & Family Welfare, Govt. of NCT of Delhi. At the time of retirement he worked as Medical Superintendent at Janakpuri Super Speciality Hospital on diverted capacity from Deep Chand Bandhu Hospita, Ashok Vihar, Delhi. He further stated that he was never under suspension during his entire service period. Neither any criminal case nor any departmental proceeding was pending against him. Also, there was no vigilance case against him. He was never chargesheet in the court of law, not even departmentally. The complainant also stated that his retirement gratuity and commuted value of pension on retirement has not been released yet inspite of several requests.

2. Facts emerged during the hearing

2.1 No representative from Deep Chand Bandhu Hospital is present. However, Shri R.K. Saini, Section Officer came in the office on 29.6.2022 and submitted status report under the signature of Dr. N.S. Khurana, Head of Office, stating the following :-

"Provisional Pension of April 2022, May2022 has been processed for release and the complainant shall get his pension from June 2022 onwards. It is requested that the matter may be closed as the claims have been settled and the grievance has redressed".

2.2 The complainant Dr. Kulen Das is not present. However, he has sent a message that " I have received my dues yesterday. It is all possible because of good people like you. Thank you very much. Regards.....Dr. Kulen Das"

3. **Directions :**

In view of the above, the Commission has decided to close the case in PGC.
