1. Brief facts of the complaint

1.1 Sh. Hemant Kumar has filed a grievance petition before Public Grievances Commission, aggrieved by non-release of arrears of withheld salaries till 14th May 2020, gratuity, bonus and other arrears arising out of 7th Pay Commission etc. by Mata Gujri Public School, G.K.1, New Delhi – 110048, where he worked till 13.02.2020 as PGT (Chemistry) Teacher. He submitted his resignation on 14.02.2020.

2. Relevant facts emerging during the hearing

2.1 Ms. Daljeet Kaur Bhandari, Principal, Mata Gujri Public School filed an Action Taken Report dated 21.07.2022, stating therein that:

"The dispute between Mr. Hemant and Mata Gujri Public School has been mutually resolved and payment of Rs.5.5 lakhs has been distributed to him as full and final settlement between him and school. All supporting documents are enclosed herewith for reference."

2.2 The complainant was not present in the hearing.

3. Directions of the PGC

3.1 Keeping in view the submissions made by the departmental representative, the case stands disposed of in the Commission.

3.2 The Commission appreciates the efforts put in by the respondent department for redressal of the grievances of the complainant.
