## Brief facts of the complaint

1.1 Shri Parveen Kumar has filed a grievance petition before Public Grievance Commission against Delhi Building & Other Construction Workers Welfare Board aggrieved by non payment of *Covid 19* relief amounting to Rs.5000/- announced by the Delhi Government.

## Facts emerged during the proceedings

2.1 Sh. Ajay Kumar, Section Officer, Delhi Building & Other Construction Workers Welfare Board, GNCTD was present in the hearing and submitted a letter dated 21.09.2021 addressed to the Branch Manager, Andhra Bank C-595 Vikaspuri, New Delhi 110018, stating therein that:

"Shri Parveen Kumar who is registered Construction Worker with this Board and as per record available, he has saving account with your bank and his Account No.126710100061770, MICR No. 110011033, IFSC Code – ANDB0001267. Further, Public Grievance Commission required his copy of Account opening form so that identity of Shri Parveen Kumar can be established (copy of order attached). Shri Parveen Kumar approached PGC for non payment of Covid 19 relief amount as per scheme of the Board and in above said order, PGC stated that Shri Parveen Kumar has not attended any of the hearings held in the Commission.

In view of above, you are requested to provide the attested copy of Account opening form in respect of Shri Parveen Kumar at the earliest, for onward submission to PGC in next hearing (03.11.2021).

This issue with the approval of the Competent Authority."

The complainant was not present in the hearing. Further, he has not attended any of the hearings held in the Commission.

## 3. <u>Directions</u>

3.1 The case was disposed of in the Commission, as the complainant was not present in any of the hearings held in the Commission and does not seems to be interested in pursuing the case. Further, the department has also resolved the grievance of the complainant by releasing the payment in respect of Covid 19 relief announced by the Delhi Government.
