Order under Para 2(B) of the PGC Resolution No. F.4/14/94-AR/dt. 25.9.97**

1. Brief Facts of the Case

- 1.1 The Management Committee of Nanda Devi CGHS Ltd., Plot 19, Sector-10, Dwarka, New Delhi has filed a grievance in the Commission on 19.01.2021 against the Office of RCS regarding completion of inspection of records for the period 2010 to 2014 of ex-President Sh. R.C. Khari for irregularities committed during the said period i.e. no audit of accounts during 2010-2014 and recovery of original document (original Share Register and Member Register etc.) not handed over to the Administrator appointed by the RCS.

2. Facts emerged during the proceedings

- 2.1 A status report dated 16.12.2021 was received in the Commission and the same was taken on record, stating therein that:

“1. This office appointed Sh.K.K. Satija as Inspecting Officer u/s 61 of DCS Act, 2003. The Inspecting Officer submitted the inspection report and on the recommendation of the Inspecting Officer, this office further appointed Sh.J.S. Rana, Deputy Secretary (Power) as Inquiry Officer u/s 62 of DCS Act, 2003 vide order dated 08.03.2021 (copy enclosed). The report is still awaited.

2. Also, this office, after taking approval from the Competent Authority, wrote a letter to the O/o Divisional Commissioner with the request to conduct search and impound the necessary record of the society and handover the same to the newly elected managing committee.”

- 2.2 Sh. Hanuman Prasad, Member of the said Society present in the hearing submitted that their main grievance is recovery of original document (original Share Register and Member Register etc.) and inspection of records for the period 2010 to 2014 for the irregularities committed during the said period i.e. no

audit of accounts during 2010-2014. He further submitted a letter dated 20.12.2021 by the President of the Society requesting therein that they would like to pursue the present grievance directly with the RCS office and therefore, requested the Commission to consider the present matter as withdrawn in PGC.

- 2.3 Sh. Naresh Kumar, Sr. Assistant, O/o RCS advised Sh. Hanuman Prasad, Member of the Society to meet the concerned Assistant Registrar Sh. Sanjay Jha for amicable resolution of all the grievances submitted by the present Management Committee of the Nanda Devi CGHS Ltd.

3. Directions

- 3.1 The Registrar, Cooperative Societies is requested to direct the concerned officer Sh. Sanjay Jha, Assistant Registrar to convene a meeting with the members of the Nanda Devi CGHS Ltd. for resolving the grievance of the complainant in an amicable manner at their own level and apprise the complainant as well as the Commission of the outcome of this grievance.

- 3.2 With these directions, the case stands disposed of in the Commission.
