## 1. Brief facts of the complaint

1.1 Sh. Ramavatar has filed a grievance petition before Public Grievances Commission aggrieved by non payment of all the retirement benefits w.e.f. 31.12.2021 (i.e. date of voluntary retirement). The complainant submitted that he had worked as P.G.T (Pol. Science) at Sarvodaya Bal Vidyalaya No. 3, Mandawali, Delhi – 110092 (School ID: 1002181). He had taken voluntary retirement after completing 25 years in government service under the Directorate of Education, GNCT of Delhi. However, his post retirement benefits and regular monthly pension has not been released by the school/Education Department till date.

## 2. Relevant facts emerging during the hearing

2.1 Sh. Inder Sain, HOS/Vice Principal, Sarvodaya Bal Vidyalaya No. 3, Mandawali, Delhi – 110092 (School ID: 1002181) filed a Status Report in the Commission. As per report:-

"Sh. Ramavatar, who has taken VRS on 31.12.2021, has been paid all

retirement benefits except Leave Encashment amount such as:-

- (i) GPF
- (ii) Insurance DGEIS
- (iii) Commutation of Pension
- (iv) Gratuity

His Leave Encashment amount is to be paid as per order of PGC. His

Leave Encashment amount is Rs.5,16,555/- but the amount to be recovered is Rs.6,18,414/-."

2.2 The complainant submitted vide his letter dated 24.08.2022 that he has been paid all terminal benefits except leave encashment by the respondent department. However, as almost all of his grievances except one grievance has been redressed by the respondent department and concerned school authorities, he wanted to withdraw his case in the Commission. He further thanked the Commission for prompt intervention in the matter.

2.3 Sh. Inder Sain, HOS/Vice Principal of the concerned school assured that the leave encashment in respect of the complainant will be credited in his bank account by the end of this month i.e. August 2022.

## 3. Directions

3.1 Keeping in view the submissions made by the departmental representative and the satisfaction expressed by the complainant, the case stands disposed of in the Commission. However, the complainant is at liberty to approach the Commission in case the school authorities/ respondent department did not release/credit the leave encashment amount in the complainant's concerned bank account by the end of August 2022.
