1. Brief facts of the case

Sh. Rajhans Bansal, C/o Centre for Human Rights, 604, Ground Floor, Shakti Khand-3, Indirapuram, Ghaziabad, Uttar Pradesh-201014, has filed a grievance in PGC aggrieved by non release of compensation under Workmen Compensation Act in respect of late Sh. Lallan and Laxman (both casual labour), who had expired due to road accident on 26.02.2022 at Keshavpuram site.

2. Facts emerged during the proceedings

2.1 Sh. Rohit, Labour Inspector, Office of Dy. Labour Commissioner (North West) filed an Action Taken Report dated 22.08.2022 stating therein that:-

"Smt. Fulwati Devi, W/o deceased Sh. Lallan Ram, Smt. Reeta Devi, W/o deceased Sh. Laxman and the injured Sh. Dharmendra Sah alongwith their counsel Sh. Ombir Singh and I.O. Sh. Naveen, S.I., P.S. Keshav Puram appeared before the Commissioner Employees Compensation on 11.07.2022. During proceeding, I.O. informed that DAR is ready for filing before the MACT. The dependants of the deceased and injured also confirmed that they wish to pursue their claim of compensation before the MACT and further requested to close the proceedings as they were not interested to file any claim of compensation under Employees Compensation. Act, 1923 before the Commissioner Employees Compensation. Hence, on the request of dependants/injured, the case has been closed with advise to pursue their claim before the MACT."

3. Directions

3.1 Keeping in view the submissions made by the departmental representative that the complainant's dependant want to pursue their claim of compensation before the MACT and have requested to close the proceedings in the Labour Department, the case stands therefore disposed of in the Commission.
