1. Brief facts of the case

The complainant filed her grievance in PGC stating that she had worked as specialist dermatologist in Delhi Government from 5.5.2015 to 2.6.2017. Her last working office was Deep Chand Bandhu Hospital. Her resignation was accepted in July 2018 w.e.f. 3.6.2017. However, payment of some of her claims have still not been released even after acceptance of her resignation letter for more than three years despite several reminders. She has requested the Commission to get her following monetary claims released to her at the earliest :-

- i. Conveyance allowance for the period 5th May, 2015 to 31st March, 2016 & 01st May, 2016 to 31st December, 2016
- ii. Newspaper allowance for the period May 2015 to September, 2016, October, 2016 to February 2017 and March, 2017 to May 2017.
- iii. Child Education allowance for Sehar Arora for the financial year 2016-2017 and March-June 2017.

2. Facts emerged during the hearing

2.1 Shri Shashi Ranjan, Senior Assistant from DCBH is present. He filed a status report, stating the following :-

" Reimbursement of Conveyance Claim for the period of January, 2017 to March, 2017 amounting to Rs. 18,622/- (Rupees Eighteen Thousand Six Hundred and Twenty Two only) has been disbursed to the applicant. (copy of authorization slip and Authorization Tracking Report is enclosed herewith.) As all the claims w.r.t. Dr. Deepshikha Khanna, Ex-Specialist, Dermatology (who was working in other hospital/s and drawing salary from this hospital) have been settled, so it is requested that the said case may be disposed off."

3. **Directions :**

In view of the above, the Commission has decided to close the case in PGC as the remaining dues of reimbursement of conveyance claim for the period of January, 2017 to March, 2017 has been disbursed to the complainant.
