**1. Brief facts of the case**

The complainant has filed a grievance in the Commission regarding non-payment of terminal benefits after the demise of her husband Late Shri Om Prakash, who was working as Safai Karmchari in Maulana Azad Medical College. He expired on 18.8.2007.

**2. Facts emerged during the hearing**

2.1 Shri Manoj Prasad, Section Officer, Maulana Azad Medical College is present at today's hearing. He submitted a status report stating the following :-

*" As per latest report received from Estate Branch, dated 07.09.2022 vide which this pension Branch has not received No Dues Certificate till date in respect of Smt. Parwati, W/o Late Shri Om Prakash, Safari Karamchari, who has neither paid outstanding dues nor vacated the Govt. Accommodation No. B-11, Type-I, behind GIPMER, MAMC Campus. So that this branch can take further necessary action for the same."*

2.2 The complainant is present and informed that she has not vacated the government accomodation yet.

**3. Directions :**

The complainant is once again advised to settle the outstanding payment towards the govt. accomodation and furnish No dues Certificate so

that the department can process her case for further release of outstanding payment of Gratuity.

With the above advice, the Commission has decided to close the case in PGC.
